Immigration and the phenomenon of multiculturalism must first be seen in terms of a chance and new opportunities, not just as a threat (...) However, this requires adequate management and preparation by the host societies, authorities and institutions – not only at the State level but above all at the regional and local level.

HISTORY OF THE "OPEN KRAKÓW" PROGRAMME

In 2011 under the partnership agreement of the Municipality of Kraków and Association Interkultarlni.pl the innovative project "Against racism and xenophobia: developing a city strategy of prevention and response" was implemented. Under this initiative the document "Draft Strategy of prevention and response to acts of racist and xenophobic nature in the city public space – a proposal for the local self-government of the City of Kraków (2012-2016)" was prepared and published in 2012. It closed the implementation of the project.

"Open Kraków" Programme draws from the content and provisions of this strategy. Its main purpose is to implement and further develop the city openness policy. Due to the actions taken by the Municipality of Kraków in terms of counteracting racist and xenophobic attitudes in the city space as well as taking into account the need of the Municipality's increasing involvement in equality activities, in April 2013, pursuant to the order of the President of Kraków no. 551/2013 of 4 March 2013 on the establishment of Task Group for drawing up a draft resolution of the Kraków City Council concerning the issues of multiculturalism, counteracting discrimination, racism and xenophobia in Kraków the work commenced on the draft resolution which, after consultations with the Kraków Board for Public Benefit Activity and non-governmental organizations, was presented to the Kraków City Council.

In 2015 the draft resolution on was re-analysed. Its provisions were amended and a new diagnosis was prepared. The document "Open Kraków" Programme once again was subject to consultations with non-governmental organizations.

On 14 September 2016 "Open Kraków" Programme was adopted by resolution of the Kraków City Council no. LII/964/16. STATISTICS CONCERNING THE RESIDENCE OF FOREIGNERS IN KRAKÓW

In accordance with statistics of the Office for Foreigners, the number of people having a valid resident permit issued by the Governor of Małoploskie Voivodeship - as of December, 31 2017 - amounted to **31,531**. Due to this fact, it may be assumed that about two thirds (about 21 thousand) live in Kraków. In accordance with the data as of July, 1 2016, the number of foreigners in Małopolska was 23,602, so about 15 thousand foreigners live in Kraków. It is therefore clear that Kraków is a place which is increasingly often chosen by foreigners as the place to live.

According to data of the Department of Administrative Affairs of the Kraków Town Hall, the number of foreigners, both those registered for permanent residence and those registered for temporary residence amounted to:

- 11,851 as of January 1, 2017,
- 15,551 as of January 2018, including:

- 2,329 people registered for permanent residence,
- 13,222 people registered for temporary residence.

The largest group includes citizens of **Ukraine - 8,105 people**, other national groups are: **Belarusians, Russians and Indians.**

Both the statistics presented by the Office for Foreigners and those provided by the Department of Administrative Affairs of the Kraków Town Hall clearly indicate that citizens of Ukraine constitute a significant group of foreigners living in Kraków.

Account should be taken that the above-mentioned statistics are not reliable because citizens of the European Union do not have to formalise their presence in Poland. This may lead to the situation that people recorded by the Voivodeship Office may, but not must, be registered in Kraków.

The activity of foreigners in business may be currently researched on the basis of the data directly submitted to the Business Activity Central Register and Information Record (CEIDG-1) in the Kraków Town Hall. In 2017 287 foreigners submitted applications for an entry into CEIDG. It must be emphasized that it is not an entire number of applications submitted because an individual person may apply for an entry into CEIDG online directly to the minister competent for economy, without the need to visit the office. The available data shows that among 287 CEIDG-1 applications, 90 were submitted by citizens of Ukraine, 22 - by citizens of Italy, 18 - by citizens of Belarus, 18 - by citizens of Great Britain. According to the partial data, citizens of Ukraine are the most active in the registration of business activity.

ACTIONS TAKEN BY THE MUNICIPALITY OF KRAKÓW TO IMPLEMENT THE "OPEN KRAKÓW" PROGRAMME

In 2017 the Municipality of Kraków took a series of actions for creating the society open to multiculturalism. Some of them were implemented under the "Open Kraków" resolution of the Kraków City Council, others, despite of the fact that they fit into the objectives of the Programme, are a continuation of activities which have been carried out in the Municipality for many years.

The programme was implemented, inter alia, by units responsible for social affairs, education, culture and national heritage, promotion and information, tourism, sport, security and crisis management and municipal organizational units: MOPS (Municipal Social Welfare Centre), SMMK (the City Guard of the City of Kraków), ZBK (Municipal Buildings Administration), ZIKiT (Administration of Municipal Infrastructure ad Transport) and ZIS (Sports Infrastructure Administration). Financial resources for performing tasks implemented under the Programme are planned every year in the budget of the city of Kraków.

I. Conferences

In 2017 under the implementation of the "Open Kraków" Programme the following conferences were held:

- "Open Kraków – the potential of diversity"

The conference was held from 23 to 25 February 2017. The event aimed at promoting activities for the development of multiculturalism and integration of foreigners residing in Kraków. It was expected to show the potential related to the presence of foreigners in the city. The conference was organised by the Kraków City Council in cooperation with Association Interkulturalni.pl, Mikołaj Rej Foundation of Supporting Culture and Polish Language and the Office Municipal Centre of Supporting Social Initiatives. Almost the entire diplomatic corps functioning in Kraków participated in it. The interest in the conference was

immense, it gathered over 120 people. The conference inaugurated a series of events referring to cultural diversity, city openness policy and integration.

"Migrations in social space of the contemporary Poland and Europe – the world context"

The conference was held from 29-30 May 2017. The main organizers included: Institute of European Studies of Jagiellonian University, Institute of Philosophy and Sociology of the Polish Academy of Science, Commission on Threats to Civilization, Polish Academy of Learning, Faculty of International and Political Studies of Jagiellonian University, Jagiellonian Centre for Migration Studies. The scientific objective of the conference was the attempt to summarize achievements to date concerning migration studies dealing with migration of Poles as well as migration processes to Poland in the context of political, economic, social and cultural processes in Europe and in the world. The most important questions which the organizers wanted to ask during the conference concerned theoretical and empirical issues of community life variability and socialization forms under the influence of migration process. They also attempted to explain in what way social sciences were theoretically and empirically enriched by migration studies.

"The Regional Seminar on Coalition-Building to Jointly Promote Tolerance and Non-Discrimination"

It was held from 8 to 10 September 2017. It was organized by the National Demographic Institute in cooperation with the Organization for Security and Co-operation in Europe (OSCE) and the Office for Democratic Institutions and Human Rights (ODIHR). The project was implemented in October 2016 and it was finished by the conference combined with the seminar in Kraków. The main purpose of the undertaking was to create coalition to combat anti-Semitism, intolerance against Muslims, Christians and other religions and beliefs as well as to combat racism and xenophobia. Participants worked on building the coalition which aimed at joint promoting tolerance and fighting against discrimination. The conference was attended by organizations working to promote human rights and civil society from Poland, Czech Republic, Hungary and Slovakia. The Office Municipal Centre of Supporting Social Initiatives supported organizers all the time during the project implementation which began with a series of workshops in November 2016. The conference summarised nearly a year's work of the group, including more than twenty organizations dealing with multiculturalism and representing cultural and ethnic minorities as well as representatives of various religions. The project contributed to establishing cooperation between the Kraków Town Hall with a few Kraków organizations which later resulted in next joint initiatives. The Kraków Town Hall participated in the preparation of "The Book of Good Practices / Actions for National and Ethnic Minorities and Foreigners", among others.

- Education in relation to Migration Language - Culture - Identity

The conference was held from 18 to 19 September 2017. It was organised by the following institutions: the Institute of Applied Linguistics of Warsaw University, the Institute for the Study of Religions of Jagiellonian University, the Centre of Studies on Education and Integration of Migrants of Pedagogical University in Kraków, the Centre for Comparative Studies of Civilisations of Jagiellonian University, the International Centre of Education of Kraków University of Technology, the Eastern European Institute of Psychology in Kiev and the Kraków Town Hall. The subject of the conference focused on considerations of participates concerning migration phenomena changing the nature of the Polish school. During the conference the problems of pupils of Polish schools who experienced migration

and do not know Polish at all or know it on a very basic level were raised. Furthermore, the discussion involved problems of cultural competences as well as the fact that education aiming at multiculturalism is still not an educational option implemented in the every day Polish school practice. According to the conference's participants, the Polish school system must develop a series of new didactical and methodical solutions. On one hand, they will open Polish schools on a broader and broader contact with cultural difference and by means of inclusive tools they will introduce new foreign students and Polish children who experienced migration to smooth functioning and further development in the Polish school and in Poland, on the other. Nowadays the post-conference publication is being prepared which will be the material for work on the Polish school problems identified during the conference for headmasters and scientific communities.

- Diversity & Inclusion Changemakers 2017 The power of gender diversity in business

The conference was held on 25 October 2017. Diversity & Inclusion Changemakers is the largest conference of D&I experts in Poland and the exceptional space created by business and for business. During the conference the subject of gender diversity was discussed. It was organized by Thing Tank University Hun, American Consulate in Kraków, and the Kraków Town Hall. The event was held under the honorary patronage of the Ombudsman – Adam Bodnar and Marshal of the Małopolskie Voivodeship – Jacek Krupa as well as President of City of Kraków – Jacek Majchrowski. Expert discussions and panel sessions were carried out by representatives of leading companies: HSBC, Luxoft, IBM and ABB, Alexander Mann Solutions, Amer Sports, BPH, Deloitte, GE, Motorola, Volksvagen.

II. Trainings

<u>Trainings for employees of the Kraków Town Hall and municipal organizational units:</u>

- Supporting integration of migrants requiring special treatment

The training was held on 4,5 and 6 October 2016. It was organized by the International Organization for Migration (IOM) and the Kraków Town Hall. The scope of training included the following issues: migration situation in the world and in Poland, intercultural competences, solving intercultural conflicts, cooperation with migrants, including persons requiring special treatment, cooperation with local community, support for people working with migrants. 15 employees of the Kraków Town Hall departments and municipal organizational units participated in the training. On 21 November 2017, within the framework of the continuation of cooperation and broadening employees' knowledge, 8 people with a study visit was delegated to Warsaw. The study visit aimed at strengthening competences of employees at the level of local self-government and non-governmental organizations, in particular employees working directly with migrants or for their integration in the local community. During the visit employees saw the Warsaw Multicultural Centre and the Warsaw Centre for Socio-Educational Initiatives.

- Enhancing the cooperation with foreigners in the practice of functioning of the local selfgovernment administration

Training was conducted on 22 December 2017. It was organized by the Regional Centre for International Debate and the Kraków Town Hall. Trainings were conducted in the form of a workshop. Foreigners who had difficulties in dealing with various matters in Kraków offices were training tutors, among others. The workshops aimed at presenting possibilities and examples, developing recommendations and potential practical improvements in the

enhancement of service for foreigners in the practice of the local self-government administration in Kraków. 12 employees who have contact with foreigners at work participated in the training.

Training for foreigners residing in Kraków:

- Within the framework of competition for implementing a public task "Activity supporting economic development, including the development of entrepreneurship" organised by the City Development Department of the Kraków Town Hall in 2017 https://www.bip.krakow.pl/?dok id=49705&vReg=1.

Non-governmental organization the Foundation of Polish and Ukrainian Cooperation under the project: "Foreigners' Entrepreneurship Support Centre" conducted the following trainings:

- trainings on operating a business, foundations of accounting and labour law;
- meetings with officials (ZUS, US, PIP, PUP, SANEPID) who presented basic issues which a person running a company may encounter https://:u-work.pl/cwpo/

Furthermore, the Office Municipal Centre of Supporting Social Initiatives commissioned conducting trainings on:

Work and Home – the life in Kraków from scratch" and "Own business for foreigners".
 Trainings were conducted in Polish and Ukrainian by the Foundation Institute of Strategic Studies.

III. Exhibitions

"Images of the Unseen"

Exhibition of Omar Marques' photos presenting the life conditions of refugees in Europe. The Kraków Town Hall under the implementation of the "Open Kraków" Programme supported the organization of the exhibition. Ms. Natalia Wiernik was a curator of the exhibition. It was presented in the space Tytano, ul. Dolnych Młynów 10 in Kraków.

IV. Other projects co-financed with the Kraków non-governmental organizations:

The Office Municipal Centre of Supporting Social Initiatives commissioned a few projects as part of commissioning public tasks to non-governmental organizations working for foreigners, national and ethnic minorities:

- Multicultural Festival – INTERKULTURALIA - October 2017. The Festival was organised by Association Interkulturalni.pl. It was held from 19 to 22 October 2017. Among many attractions, inter alia, workshops for foreigners, debates, cooking and educational workshops and screenings of movies were organised. At the end of the festival the Concert Mamadou&SamaYoon. The Festival has permanently appeared on the Kraków cultural map. This year it was already the third edition of the festival.

- "Next door"

The task implemented in November-December 2017. The project was carried out by ZUSTRICZ Foundation. It was held in the cycle of six meetings and each of them will be devoted to one issue – the leitmotiv. At the beginning the organizers chose tradition and culture because they allow participants to discover common roots and universal values. Next meetings will address such topics as: economy and entrepreneurship, religion and the most important holidays, geography and tourism as well as cuisine. At the end of the project

organizers planned group celebration and party. The meetings in the form of interactive activities, workshops, lectures, discussion panels which were held in regular time intervals from November to December. - "Christmas cooking and educational workshops"

The project was carried out by the Foundation of the Polish and Ukrainian Cooperation U_Work. During meetings in the Foundation's seat participants got familiar with Polish and Ukrainian Christmas customs. As part of the programme the Civic Initiative Fund Lesser Poland Locally (FIO Małopolska Lokalnie) run by the Foundation Office of Social Initiatives with the financial support of, inter alia, the Municipality of Kraków, the following multicultural projects were implemented:

My, Your, Our, Faces of Kraków:

The project is a photo essay, the protagonists of which are inhabitants of Kraków who represent different nationalities, ethnic and religious groups. 12 interviews and photo sessions were conducted, together with a multicultural debate and educational meetings.

In September 2018 the exhibition will be presented in the main lobby of the Kraków Town Hall.

New Kraków inhabitants are getting familiar with their city: as part of the project a series of information meetings for students-foreigners were organized during which new inhabitants found out about the student life in Kraków. Two walks among places which are famous and important for every Kraków inhabitant were organized. The "Toolbox" with important information for foreigners studying in Kraków was prepared. Additionally, participants of the project received a toolbox "Tutorial concerning the student life in Kraków" in Polish, Ukrainian, Belarussian and Russian.

The project was implemented by the informal group Krakowskie Słowianki with the support of the Foundation of the Polish and Ukrainian Cooperation U_Work.

V. Police and City Guard – safety actions:

The problem of signing buildings with scrawl and acts of vandalism related to hate speech is registered and liquidated by municipal services. In 2017 in the Municipality of Kraków the City Guard reported: **976 acts of vandalism** concerning signing buildings (580 removed), 16 perpetrators signing buildings with scrawl were detected. Furthermore, within the framework of combating illegal inscriptions on walls **976 pieces of advice were given to owners and building administrators**.

On the City Guard's Internet website there is "The guide for owners of real estate damaged by scrawling or illegal announcements and posters". For the purposes of social prevention at schools and among inhabitants 240 lessons in 6th grades and 320 lessons on "the liability of minors" were carried out in gymnasiums, secondary schools, and other facilities. During these lessons the provisions of the Code of Petty Offences, Criminal Code and the Act on monument protection and care which forbid to place illegal inscriptions and drawings were discussed together with legal consequences of such acts.

Since January 2017 the proceedings carried out by the Municipal Police Headquarters concerning hate crimes, i.e. prohibited acts committed due to racism and xenophobia have been monitored:

- -29 proceedings instigated due to crimes motivated by hatred, i.e. acts under Article 118, 119, 256§1, 257, 199 of the Polish Criminal Code and Article 55 of the Institute National Remembrance Act.
- 6 preparatory proceedings concerning crimes committed via Internet (hate speech).

Furthermore, the Police carry out educational activities related to the prosecution of crimes motivated by prejudice. Policemen of the Municipal Police Headquarters held a total of 261 meetings, during which the issues related to racism and xenophobia were discussed. Furthermore, educational activities related to the fight against the so-called scrawling were carried out, within the framework of which 575 lessons were given at schools. Policemen working in the Criminal Prevention, Juveniles and Social Pathology teams of the Municipal Police Headquarters in Kraków are properly prepared and they implement the project "Cyber threats, prevention, response" on an ongoing basis. Furthermore, they carry out external trainings for educational facilities in the City of Kraków targeted at pupils, their parents and teachers, during which the crime under Article 256 of the Polish Criminal Code is discussed, i.e. inciting (persuading, encouraging, inducing, provoking, no matter if it was effective) hatred based on national, ethnic, race or religious differences or for not being religious is sowing hate, i.e. a strong reluctance, hostility towards other person or people.

In 2017 policemen of the Municipal Police Headquarters participated in internal trainings in combating crimes motivated by hatred. Trainings were monitored by the Human Resources Department of the Municipal Police Headquarters in accordance with the principle of cyclicality. Policemen who were not trained in previous years are cyclically referred to PZPN trainings, i.e. in hate crime prevention and combat.

MULTICULTURAL KRAKÓW – CULTURAL EVENTS IN KRAKÓW

In 2017 the Kraków Festival Office and the Department of Culture and National Heritage organized several dozens of events promoting culture of artists from other countries or referring to the Kraków idea of multiculturalism. The report presents those which are the most often connected with the openness of the city to other cultures, ethnic groups or foreigners visiting and most of all residing in Kraków.

 Organization of 41st Session of the UNESCO World Heritage Committee which was held in Kraków in the ICE Congress Centre on 2-12 July. For the first time Poland was the state-host of the session. In 1978 among first 12 facilities the historical part of Kraków including Old Town, Wawel Hill and the district Kazimierz with Stradom were entered into the World Heritage List of UNESCO.

- Night Cracovia Sacra held every year on 14/15 August. In terms of form, nature and richness it does not have any counterpart in the whole Europe. Since the early centuries Kraków has been an important centre of various religious thought. For the whole centuries until the present day the phenomenon of the city's spiritual culture and religious culture has been highlighted. Since 2008 the Nigh Cracovia Sacra has been accompanied by the leitmotiv which in 2017 were treasures of Kraków monasteries. The undertaking enjoys a great interest of inhabitants as well as national and foreign tourists. Every year almost 30 000 people participate in the event.
- From August to October cultural events presenting an Armenian motif in the history of culture of Kraków were organized in relation to the national celebration of 650th anniversary of Armenians' presence in Poland – a series of lectures on Armenian language and culture prepared by Kraków scientists.
- In October 2017 a special supplement to Tygodnik Powszechny was developed and published. It was devoted to Tadeusz Kościuszko in the context of Polish and American issues on the 200th anniversary of his death.
- Additionally, in 2017 the diversity and multiculturalism of the city was presented within the framework of the Jewish Culture Festival in Kraków co-financed from the budget of the Municipality of Kraków (the Department of Culture and National Heritage) and the International Days of Roma Culture in Kraków. The above-mentioned cyclical undertakings received, as every year, a subsidy as part of an open competition for implementation of public tasks of the Municipality of Kraków in the field of culture, art, protection of cultural goods and national heritage.
- Many undertakings co-financed under the above-mentioned open tenders characterise by diversity and multiculturalism although they are not a dominant part in their programme. It is worth mentioning a co-financed annual activity of Decius Villa Association "Forum of Culture Dialogue", Foundation Judaica "Heritage, Remembrance, Civil Community" and the Society of Friends of History and Monuments in Kraków "Kraków in the history of nation", as part of which the policy of openness to multiculturalism and cooperation with foreigners (e.g. ICORN) is implemented.
- International Cities of Refugee Network ICORN is an organization associating cities and regions offering shelter for persecuted writers. It aims at providing writers who become politically persecuted due to their literary output with safe conditions for life and work. ICORN builds a strong and dynamic network based on the international solidarity, constituting one of the strongest voices in the world in defence of the right to freedom of opinion and speech. Over 40 cities belong to ICORN network, including Brussels, Frankfurt, Miami, Stockholm and Mexico. The official website of the organization: www.icorn.org. The City of Kraków was invited to join ICORN as the first member city of Central and Eastern Europe. In the invitation for the Kraków City Council ICORN executive bodies indicated Kraków as an important candidate which will serve as a perfect model for other cities of this region of Europe. In the course of two years of its membership in ICORN Kraków hosted two writers: Maria Amelie - a writer with Russian background who, having written a book describing experience of an illegal immigrant, was deported to Norway and Kareem Amer an Egyptian blogger sentenced to four years of imprisonment for criticizing Hosini Mubark's government. In accordance with the order no. 735/2017 of President of the City of Kraków of 27 March 2017 Kraków continues its membership in the International Cities of Refugee Network (ICORN).

ACTIONS TAKEN BY THE MUNICIPALITY OF KRAKÓW FOR FOREIGNERS PURSUANT TO SOCIAL WALFARE ACT

In 2017 **the Municipal Social Welfare Centre** provided foreigners residing in Kraków with the following assistance:

- Number of foreigners benefiting from a purpose-specific benefit: 120 people in 55 families.
- Number of foreigners included in the Individual Integration Programme: 16 people in 3 families (country of origin: Ukraine).

As part of the Individual Integration Programme the following support was provided:

- 16 people obtained the cash benefit intended to cover the expenses for expenses for food, clothing, footwear, personal hygiene and housing fees as well as to cover expenses of learning of the Polish language,
- 16 people were provided with the assistance with the form of social work,
- 16 people were provided with information and support in contacts with other institutions, in particular labour market institutions, local community and non-governmental organizations.

Apart from the Individual integration Programme, the support was provided to:

- 3 foreign children in two foster families (2 Romania, 1 Hungary) benefited from assistance in the form of cash benefits for foster families (assistance granted pursuant to the Act of 9 June 2011 on supporting families and foster care system),
- 8 foreign children (2 Ukraine, 2 Hungary, 2 Latvia, 1 without any citizenship, 1 with an unsettled legal regulation) benefited from the assistance in the form of covering the maintenance expenses in the educational care centre,
- 10 foreign children had their health insurance contributions paid (2 Ukraine, 3 Hungary, 2 Latvia, 2 Romania, 1 without any citizenship),
- 11 people with the Belarussian (2), Ukrainian (6), Azeri (1) and Roma (2) citizens were provided with the assistance in the form of social work,
- 9 people with the Belarussian (2), Ukrainian (6), Azeri (1) participated in lessons within the framework of voluntary work.

Furthermore, the Municipal Social Welfare Centre implemented the following actions:

- Organization of the anti-discrimination workshops for people under 25 years of age 13
 people participated in 2 meetings.
- Organization of 8 meetings concerning refugees for pupils of Kraków primary schools within the framework of the Young Cracovian Academy. 171 people took part in workshops.
- Organization three initiatives in three districts: Azory, Krowodrza and Olsza during which the
 local community attention was focused on the idea of protection and taking care of the
 quality of public space through painting murals. One of these events was targeted at young
 people and was conducted by Mexican Culture Foundation. About 90 people participated in
 activities.
- Cooperation with the Polish-Bulgarian-Ukrainian Project Neighbouring Circle of ZUSTRICZ
 Foundation within the framework of the task "Picnics for Nowa Huta inhabitants" financed
 by the participatory budget. During one of four picnics collective singing of songs of various
 countries, international refreshments, screening of the film from workshops which activate,
 include and prevent foreigners residing in the Municipality of Kraków from being excluded
 took place, among others. About 100 people participated in the picnic.

ACTIONS TAKEN BY THE MUNICIPALITY OF KRAKÓW FOR FOREIGNERS PURSUANT TO ACT ON THE EDUCATION SYSTEM

Integration of pupils from the immigrant families consists in taking all measures aiming at eliminating difficulties experienced by pupils from abroad. It concerns, inter alia: language barrier, fear of cultural distinctiveness. Furthermore, such actions are expected to counteract their social exclusion, give them a good start on the labour market in relation to acquired skills and motivate them to actively participate in social life. For this purpose, inter alia, the innovative programme "Educational Multicultural Kraków" was established. It is implemented in the Primary School no. 4, XLII Secondary School and V Secondary School. The main objectives of the programme include:

- Implementation of children of Polish citizens who return from abroad with an insufficient knowledge of Polish to obtain education and facilitate learning in the Polish education system for foreigners.
- Initiating and supporting the development of the Polish multicultural society with the special attention paid to the spread of the idea of multicultural society among children and youth,
- Developing and strengthening attitudes oriented towards active cooperation in the development of multicultural civil society in Poland, building of social integration with the special attention paid to children and youth from national and ethnic minorities,
- Developing programmes supporting integration activities, building mutual respect and tolerance,
- Supporting social mobility and assistance in re-adaptation,
- Providing foreigners with the possibility of integration with maintaining their cultural and religious individuality at the same time.

Furthermore, since 2017 by order of the president of the City of Kraków no. 2356/2017 on amending the order 80/2017 on setting down regulations stipulating principles of co-financing of some form of continuing professional development for teaching staff employed in schools and facilities run by the Municipality of Kraków the development in multicultural education and intercultural education was regarded as the priority direction of professional development of the teaching staff. The amendment of the order resulted both from local needs and directions of educational policy adopted for the school year 2017/2018 (strengthening the pedagogical role of the school). This form of development is particularly recommended to tutors and guidance counsellors. Refunding costs for teachers obtaining qualifications in multicultural and intercultural education amounts to 80%. Since April 2015 teachers have been obtaining qualifications to teaching Polish as a foreign language. Since September 2016 refunding has been 95%. Since 2016 more and more teachers have been benefiting from this form of training. In 2017 52 teachers benefited from co-financing for their studies (in total 93 teachers has benefited from the co-financing since 2016 – the Municipality allocated a total amount of PLN 220,598 for this purpose).

Due to increasing number of pupils-foreigners at schools in the Municipality of Kraków, on 1 February 2018 the teaching consultant on multiculturalism was appointed. He/she supports teachers working with classes in which children with other citizenships learn. He/she carries out his tasks in the Specialized Early Psychological and Pedagogical Assistance Counselling Centre and the Complex of Secondary Schools no. 18 at ul. Św. Gertrudy 2 in Kraków. In accordance with the order of the President of the City of Kraków no. 159/2018 of 24 January 2018 MA Urszula Majcher-Legawiec was appointed to the above-mentioned position.

On the basis of the data from Educational Information System:

• The number of children-foreigners learning in Kraków schools: primary, publicly available, special schools for children and youth (local self-government and non-local self-government), without taking into consideration schools for adults and nursery schools, pre-school

departments in primary schools and other forms of preschool education amounts to: **1280** pupils;

- The number of children-foreigners who benefited from free-of-charge Polish language learning: **598 pupils** (no data on the number of hours);
- The number of pupils, children-foreigners who benefited from the so-called compensatory classes: **170 pupils** (no data on the number of hours);
- The number of pupils, children who benefited from Ukrainian language lessons organized in the Integration Secondary School Complex no. 1 nowadays the primary School with Integration Units no. 12: **9 pupils.**

The Resolution LII/964/16 on the implementation of the "Open Kraków" programme adopted by the Kraków City Council on 14 September 2016 was being implemented for the whole year which allowed for planning funds for new tasks arising from its content.

In 2017:

- the platform of cooperation between representatives of minorities and foreigners with the local self-government was built,
- the principles of an open competition were prepared. As a result, in 2018 the Information
 Point in Kraków providing inhabitants with the service in foreign languages will be launched;
 it will allow foreigners to obtain advice concerning the provisions of law, economic activity,
 improving professional qualifications, education of children and adults, social and residential
 assistance,
- preparation to an important task which is translating official procedures most often used by persons taking up employment and studies in Kraków started,
- the obligatory provision concerning anti-discrimination clauses was introduced to agreements of rent, lease or lend of use concluded by the Municipality,
- the cooperation with private entities was established in order to develop joint activities for openness towards other cultures and nationalities,
- a dozen or so events corresponding to the idea of multiculturalism (vernissages, conferences, cyclical festivals) were supported and organised, funds as part of open competitions for implementation of public tasks were transferred and used in educational and cultural projects devoted to multicultural heritage of Kraków,
- departments of the Kraków Town Hall and municipal organizational units which so far have not been implementing tasks in this field were included into implementation of actions for open and multicultural Kraków;
- building of a network of organizations working for multiculturalism of the city was started, it
 will influence the building of a new quality of life of foreigners who chose Kraków as a place
 of residence;
- THE INTERDISCIPLINARY TEAM ON COOPERATION FOR IMPLEMENTATION OF THE "OPEN KRAKÓW" PROGRAMME started operating, among others.

The Office Municipal Centre of Supporting Social Initiatives is taking active measures to broaden the knowledge on statistics and data related to the life of inhabitants-foreigners. Furthermore, it is also widening environments of cooperation in building the multicultural and open city which will draw strength and development equally from all its inhabitants.
